CENTRAL GAME PERFORMANCE DATABASE

The EILERS-FANTINI Central Game Performance Database (GPD) collects and tracks relative slot machine performance data provided by individual casinos on a monthly basis and then standardizes and aggregates the data. All data is held in a secure online database and no individual casino data is viewable. Database subscribers are able to look up game performance information on individual games as well as create custom performance reports tailored to their specific business needs and geographic location.

CASINO PARTICIPATION

- In return for supplying monthly game performance data, participating Casino Operators will receive a free monthly game performance report and cabinet level performance report, as well as free access to the online database for custom analysis and data extraction.
- The value proposition of the GPD is similar for Casino Operators who participate in the EILERS-FANTINI Slot Survey whereby participants receive a free copy of the summary results in exchange for participating.
- The GPD is an extension to the EILERS-FANTINI Slot Survey, which is the gaming industry's largest survey tracking purchasing trends on over 500,000 slot machines worldwide.
